The Council of the College of Physicians and Surgeons directs that, pursuant to section 47.5 and 47.6 of **The Medical Profession Act, 1981**, the Discipline Committee hear the following charges against Dr. Mohammed Nural Haque, namely:

 You, Dr. Mohammed N. Haque, are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(o) and/or section 46(p) of **The Medical Profession Act**, **1981** S.S. 1980-81 c. M-10.1 and/or bylaw 7.1 (b) and/or bylaw 7.1(c), and/or bylaw 7.1 (g) paragraphs 21, 22 and 24 and/or bylaw 8.1(b)(ix) of the bylaws of the College of Physicians and Surgeons of Saskatchewan.

- (a) A female person hereinafter referred to in this charge as Patient Number 1 was your patient;
- (b) On or about May 22, 2007 Patient Number 1 presented to you with bladder discomfort and frequency of urination;
- (c) On or about June 26, 2007 Patient Number 1 presented to you with vaginal bleeding;
- (d) You failed to appropriately investigate the cause for Patient Number 1's vaginal bleeding;
- (e) On or about the 11<sup>th</sup> day of April, 2008 you performed surgical procedures on Patient Number 1;
- (f) You performed the surgical procedure without adequately explaining the surgery which you intended to perform;
- (g) You performed the surgical procedure without obtaining informed consent from Patient Number 1 to perform the surgery;
- (h) Patient Number 1's presenting problem was a bladder problem;
- (i) The surgical procedures which you performed were not indicated for the presenting bladder problem;
- (j) The procedures which you performed were not the same procedure(s) as the patient had expected;
- (k) You did not perform an adequate preoperative assessment before performing the surgical procedures;
- You performed the procedures in such a manner that it resulted in a reduction in the size of her vagina and painful intercourse;
- You did not advise Patient Number 1 that the surgical procedure which you would perform could result in a reduction in the size of her vagina or painful intercourse;
- You, Dr. Mohammed N. Haque, are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(o) and/or section 46(p) of The Medical Profession Act, 1981 S.S. 1980-81 c. M-10.1 and/or bylaw 8.1(b)(ix) and/or bylaw

8.1(b)(xvi) of the bylaws of the College of Physicians and Surgeons of Saskatchewan.

- (a) A female person hereinafter referred to in this charge as Patient Number 2 was your patient;
- (b) Patient Number 2 presented to you with a complaint of a foul yellow discharge;
- (c) You failed to adequately investigate the complaint and failed to test Patient Number 2 for a possible sexually transmitted infection;
- (d) You made sexualized or sexually-demeaning comments to Patient Number 2;
- (e) You requested details of Patient Number 2 sexual history or sexual likes or dislikes when not clinically indicated;
- (f) You initiated a conversation with J. M-W regarding your sexual, preferences or fantasies;
- (g) You engaged in conduct with Patient Number 2 which was sexual or was reasonably interpreted as sexual by Patient Number 2 by touching her breast or breasts and/or touching her in the region of her genitals other than for the purpose of an appropriate examination or treatment;
- (h) You asked Patient Number 2 about her sex life when she had not presented to you with sexual concerns;
- (i) You asked Patient Number 2 whether she was "tight down there";
- (j) You asked Patient Number 2 about her orgasms when she had not presented to you with sexual concerns;
- (k) You initiated a discussion with Patient Number 2 about the "G spot" and its effect on women's orgasms;
- (I) You asked Patient Number 2 whether she had experienced anal intercourse;
- (m) You told Patient Number 2 that you would demonstrate sexual positions for anal intercourse;
- (n) Following your question to Patient Number 2 about her experience with anal intercourse, you instructed her to turn around so that you were facing her buttocks. You then pressed your body against her buttocks and placed your hand in the region of her genitals, suggesting her boyfriend should touch her there;
- (o) You began a conversation with Patient Number 2 in which you discussed having her boyfriend placing his penis between her breasts and stated that she could allow men to ejaculate into her face;
- (p) you placed your hand or hands on Patient Number 2's breast or breasts for a purpose other than an appropriate medical examination;
- (q) After placing your hands your hand or hands on Patient Number 2's breast or breasts you made a comment to the

effect that she had large breasts and stated that "guys like that", or used words of similar meaning;

- (r) You initiated a conversation with Patient Number 2 about removing her pubic hair and that told her that men do not like women to have pubic hair.
- (s) You initiated a conversation with Patient Number 2 in which you stated that some women like to leave a strip of pubic hair;
- (t) You touched Patient Number 2's pubic region while making these comments about her pubic region.
- You Dr. Mohammed Nural Haque are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(o) and/or section 46(p) of The Medical Profession Act, 1981 S.S. 1980-81 c. M-10.1 and/or bylaw 8.1(b)(ix) and/or bylaw 8.1(b)(xvi) of the bylaws of the College of Physicians and Surgeons of Saskatchewan.

The evidence that will be lead in support of this charge will include the following:

- a) A female person hereinafter referred to in this charge as Patient Number 3 was your patient;
- b) On or about the 18<sup>th</sup> day of September, 2001 Patient Number 3 attended upon you in connection with her pregnancy;
- c) You performed a transvaginal ultrasound examination on Patient Number 3;
- While performing the transvaginal ultrasound examination on Patient Number 3, you placed your hand, fingers and/or thumb on the patient's clitoris;
- e) While performing the transvaginal ultrasound examination you rubbed the patient's clitoris;
- f) Your conduct was such that it was sexual or was reasonably interpreted by Patient Number 3 as sexual;
- g) Your conduct was such that you failed to maintain the standard of practice of the profession.
- 4. You Dr. Mohammed Nural Haque are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(o) and/or section 46(p) of The Medical Profession Act, 1981 S.S. 1980-81 c. M-10.1 and/or bylaw 8.1(b)(ix) and/or bylaw 8.1(b)(xvi) of the bylaws of the College of Physicians and Surgeons of Saskatchewan.

The evidence that will be lead in support of this charge will include the following:

a) A female person hereinafter referred to in this charge as Patient Number 4 was your patient;

- b) In or about the year 2007 Patient Number 4 attended upon you as she had not had menstruated for some time;
- c) You remained in the room while she began to dress;
- d) You then advised Patient Number 4 that there was another matter you wanted to speak to her about;
- e) While Patient Number 4 was seated on the examination table you approached her and pulled her legs apart;
- f) You placed your finger in close proximity to Patient Number 4's clitoris piercing
- g) You commented that you most commonly see patients with their clitoris pierced in the opposite direction, or made a statement of similar meaning;
- h) The fact that Patient Number 4 had a piercing of her clitoris was not related to the medical condition with which she had presented;
- i) You then lifted Patient Number 4's gown which exposed her breasts;
- j) You asked Patient Number 4 if she had ever considered having her nipples pierced, or used words of similar meaning;
- k) You then touched her nipples;
- Your discussion with Patient Number 4 related to nipple piercing was not related to the medical condition with which she presented;
- m) Your touching of Patient Number 4's nipples was not related to the medical condition with which she presented;
- n) Your conduct was such that it was sexual or was reasonably interpreted by Patient Number 4 as sexual;
- o) Your conduct was such that you failed to maintain the standard of practice of the profession.
- You Dr. Mohammed Nural Haque are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(o) and/or section 46(p) of The Medical Profession Act, 1981 S.S. 1980-81 c. M-10.1 and/or bylaw 8.1(b)(ix) and/or bylaw 8.1(b)(xvi) of the bylaws of the College of Physicians and Surgeons of Saskatchewan.

- a) A female person hereinafter referred to in this charge as Patient Number 5 was your patient;
- b) Patient Number 5 consulted you due to a concern about a vaginal discharge;
- c) You instructed Patient Number 5 to remove all of her clothing;
- You did not provide an explanation why Patient Number 5 was required to remove the clothing on her upper body;

- e) You instructed Patient Number 5 to dress in a gown so that it opened at the front;
- f) When you first came into the examination room, Patient Number 5 had not removed the clothing from her upper body;
- g) You left the room and advised Patient Number 5 to remove all of her clothing;
- h) When you returned to the Examination Room, you opened Patient Number 5's gown;
- i) You placed your hands upon Patient Number 5's breasts;
- j) You did not perform an appropriate breast examination on Patient Number 5;
- You did not obtain consent from Patient Number 5 to place your hands on her breasts;
- I) You did not provide an explanation to Patient Number 5 for placing your hands on her breasts;
- m) Your placing your hands on Patient Number 5's breasts was not related to the medical condition with which she presented;
- n) Your conduct was such that it was sexual or was reasonably interpreted by Patient Number 5 as sexual;
- o) Your conduct was such that you failed to maintain the standard of practice of the profession.
- You Dr. Mohammed Nural Haque are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(o) and/or section 46(p) of The Medical Profession Act, 1981 S.S. 1980-81 c. M-10.1 and/or bylaw 8.1(b)(ix) and/or bylaw 8.1(b)(xvi) of the bylaws of the College of Physicians and Surgeons of Saskatchewan.

- a) A female person hereinafter referred to in this charge as Patient Number 6 was your patient;
- b) Patient Number 6 consulted you for an ultrasound as she was pregnant;
- c) You began to undo Patient Number 6's pants as she lay on the Examination Table.
- d) You spoke to Patient Number 6 about how she should wash her nipples;
- e) You did not obtain consent from Patient Number 6 to place your hands on her breasts;
- f) You did not provide an explanation to Patient Number 6 for placing your hands on her breasts;
- g) Your placing your hands on Patient Number 6's breasts was not related to the medical condition with which she presented;
- h) Your conduct was such that it was sexual or was reasonably interpreted by Patient Number 6 as sexual;

i) Your conduct was such that you failed to maintain the standard of practice of the profession.
